# DID YOU KNOW...?

*Did you know* that during the academic year 2015/2016 the College of Business is celebrating its 50<sup>th</sup> of being a part of the UTA community?

*Did you know* that *U.S. News & World Report* ranked the UT Arlington College of Business Part-time MBA program No. 82 among 470 accredited programs surveyed? This is the first time the college has broken into the Top 100 on the *U.S. News* list.

*Did you know* that AACSB-accredited schools have the highest-quality faculty, deliver relevant and challenging curriculum, and provide educational and career opportunities that are not found at other business schools? Less than 5% of the more than 16,000 schools worldwide granting business degrees have earned AACSB Accreditation. Of that small number of AACSB accredited colleges of business, only 179 have dual accreditation of both the college and the department of accounting. UTA has dual accreditation of both the college and the department of accounting.

*Did you know* that Accounting Degree Review has ranked the University of Texas at Arlington's bachelor's degree in accounting as one of the most affordable in the nation? UT Arlington ranked 25<sup>th</sup> out of 170 institutions accredited by the Association to Advance Collegiate Schools of Business (AACSB), the organization founded in 1916 to accredit schools of

"UT Arlington accounting graduates are in high demand. Our program's quality has been widely recognized. This additional ranking further confirms our position as one of the best options for students to consider," Croson said.

## JEFF SLATE DISCUSSES FASB REVISED REVENUE RECOGNITION STANDARDS

In September, Mr. Jeff Slate made a presentation to Department of Accounting faculty concerning the recent FASB Revised Standards for Revenue Recognition for Customer Contracts.

Jeff, the 2014 recipient of the Accounting Distinguished Alumni award, is a partner in Ernst & Young's Dallas office, where he is a member of EY's Southwest Region's Assurance Professional Practice and Risk Management group.

Prior to this role, Jeff spent approximately seven years in Ernst & Young's National Accounting Standards group in New York,

where, among other responsibilities, he led the Ernst & Young professionals focused on the application and development of interpretive guidance for, various standards relating to revenue recognition for both United States GAAP and IFRS.

Jeff has been a member of the AICPA's Accounting Standards Executive Committee (AcSEC), the FASB's Revenue Recognition Resource Group, and Ernst & Young's Global IFRS Revenue Recognition Subject Matter Group. Jeff is a 1989 graduate of the University of Texas at Arlington, and is a licensed CPA in the States of Texas and New York.
