## GREETINGS FROM THE CHAIR

Welcome to the spring edition of the UTA Department of Accounting newsletter. The fall semester was a busy semester getting the Fifth Year Accreditation Report ready for the AACSB. The AACSB Accreditation team will be visiting the Accounting Department and the College of Business February 20-22. The Department of Accounting was one of the first in the country to receive separate accreditation by the AACSB in 1984, and today is one of only 175 schools in the country that has such a distinction. We hope to continue that tradition.

Our students have consistently done well on the CPA exam. To improve the quality of the accounting program, we continue to make changes in the curriculum. For many years, we have offered several courses in accounting beyond those required to graduate with a Bachelors in Accounting. This was done to facilitate eligibility for undergraduate students to sit for the CPA exam. As of fall 2011, the department has decided to reduce the number of courses offered in the undergraduate program to 24 credit hours of accounting beyond Principles. This decision allows us to increase courses in the Masters program. Students interested in achieving eligibility for the CPA exam are strongly encouraged to get a Masters degree in Accounting. In order to financially support undergraduate students in pursuing a Masters degree in Accounting, the department is in the midst of raising funds for the Endowed Graduate Scholarship in Accounting. We are hopeful that the scholarship will encourage and motivate highly qualified students to continue and succeed in their graduate education at UTA.

There has been a long tradition of excellence in the department. We not only have high quality teachers as was identified in the last newsletter with three of our faculty receiving college teaching awards, we have faculty publishing consistently in academic and practitioner journals.

Last semester, Dr. Billy Brewster received notice that his paper had been accepted at <u>The Accounting Review</u>, the foremost academic journal in accounting. Dr. Stephanie Rasmussen's paper was selected for the CAR conference and will be forthcoming in <u>Contemporary Accounting Research</u> journal. Two other faculty, Dr. Tom Hall and Dr. Jeff Tsay published a piece in a premier AAA section journal, <u>Auditing: A Journal of Theory and Practice</u>. I would like to congratulate all of them. ## Spotlight on: Professional Program in Accounting (PPIA)

The PPIA is an integrated five-year program that allows students to concurrently earn a bachelor's degree (either BBA-Accounting or BS-Accounting) and a master's degree (either MS-Accounting or MS-Taxation). The advantage of this program is that it permits students to earn both accounting degrees with fewer semester hours (and at a lower cost) than would be necessary if both degrees were pursued separately. # VITA & UTA

Accounting students from UTA serve as volunteers on behalf of the working poor of Tarrant County in the VITA program run by Foundation Communities of Arlington and Catholic Charities, Diocese of Fort Worth. Volunteer Income Tax Assistance (VITA) provides free income tax preparation for these hard working families. By using VI-TA, families are able to maximize deductions and credits available to them and avoid expensive tax preparation services and high interest refund anticipation loans (similar to payday loans). VITA also provides referrals for additional social and financial educational services.

In 2010 VITA volunteers in Arlington helped to prepare 1,300 tax returns and brought \$1,654,353.00 in refunds back into the community. While these refunds represent a huge impact on individual families, the economic affect on our community is even more impressive. The IRS estimates that for every \$1 received in Earned Income Tax Credit, \$2 is returned to the surrounding community.

UTA VITA volunteers serve as intake specialists, tax preparers, and quality reviewers. Volunteers train for an average of 16 hours and become certified by the IRS using their VITA curriculum. In 2010, we had 19 students volunteer for more than 350 hours between January 15 and March 15.

UTA will be participating in VITA again this spring. We hope to increase the number of volunteers dramatically. Over 50 students have already expressed interest in volunteering their time. If you would like to volunteer please contact Terra Brown McGhee at tcbrown@uta.edu for more information.

# UTA Internship Program & YOU ...

The Department of Accounting organized the first annual internship preparation program last fall. Over 100 students participated in the program, designed to prepare students for the busy spring recruiting season. Participants polished their job search skills with resume critiques, mock interviews, an orientation to services provided by The Career Center, lectures on what to expect during the recruitment process, and workshops on Dining Etiquette, Business Etiquette and Networking Skills. These newly polished students will be actively pursuing internship opportunities during the spring semester. Sixty or more UTA accounting students enroll in the internship course each year for college credit, while many more students complete internships on their own.
