#### **Presentation on Campus Carry**

John Hall, Campus Operations vice president, gave a presentation about campus carry. Texas Senate Bill 11, commonly known as the campus carry law, allows for concealed handgun license holders to carry their concealed weapons into building on college campuses. Key dates in the implementation process:

- 1. November 1: Consensus recommendations regarding any categories of space to be designated as exclusion zones on campus. (President develops rules, regulations and provisions for System and Board of Regents' consideration.)
- 2. December 4: President submits preliminary campus plans to UT System Administration
- 3. December 11: UT System provides feedback to presidents
- 4. December 18: President submits final plan to UT System Administration
- 5. February 10: Board of Regents meets and reviews campus plans
- 6. February 15: Campuses begin implementing plans
- 7. July 1: All new physical plant facilities such as storage lockers and signage are in place
- 8. August 1: Law takes effect
