Dr. Jackson noted that UTA has been named in the elite group of R1: Doctorial Universities. This is the highest Research Activity ranking bestowed the Carnegie Classification of Institutions of Higher Education. Dr. Jackson reminded the GA of the ACES Symposium scheduled on Wednesday, March 23 in the University Center. He asked the GA members to encourage their students to participate by submitting an abstract or volunteer as moderators or PhD judges.

The Thesis and Dissertation Manual is current at the Library. The manual should be available on the Library and OGS website soon. The departments should notify their students of the OGS and Library websites for information.
